Building Services Operation and Maintenance Executives Society Technical Talk on “New Requirements on Code of Practice for Fire Safety in Buildings 2011 related to Property Maintenance and Management”

Programme Highlights

Following a review of the Code of Practice for the Provision of Means of Escape in Case of Fire 1996, the Code of Practice for Fire Resisting Construction 1996 and the Code of Practice for Means of Access for Firefighting and Rescue 2004, the **Code of Practice for Fire Safety in Buildings 2011** had been issued by Buildings Department recently to replace the said three Codes of Practice and to provide guidance in compliance with the requirements laid down in the Building (Construction) Regulation 90 and the Building (Planning) Regulations 41, 41A, 41B, 41C and 41D, which include the requirements for fire resisting construction, means of escape and means of access for firefighting and rescue to buildings. In addition, it also provides guidelines on the testing standards for the fire properties of building elements and components, fire safety management of buildings and the alternative approach in fire safety design, i.e. fire engineering approach.

The new **Code of Practice for Fire Safety in Buildings 2011** will be fully implemented on 1st April 2012 and during the period the concerned parties are opted to follow either the current Codes or the new Code but not a mixture of both. In order to facilitate our members in implementing as well as to understand the major changes of the new Code, Building Services Operation and Maintenance Executives Society (BSOMES) has organized a technical talk on this new Code with the details as shown below.
